HOW TO ENTER

Beginning at 9:59 a.m. Eastern Time (“ET”) on October 30, 2007, entrants can enter the “TLNTV.COM Daily Cd Giveaway” contest (the “Contest”) by registering online at www.tlntv.com (the “Website”). All entries must include your full name, complete address (including city, province of residence, and postal code), daytime phone number with area code, age and e-mail address. Limit of one entry per e-mail address per person per day. In the event it is discovered that any individual attempted to enter more than once per day, all of that individual’s entries (past and future) will be disqualified from this Contest. Any use of automated devices is prohibited.

The Sponsors of this Contest are Telelatino Network Inc (TLN) and Sony BMG Canada (collectively, the “Sponsors”).

DAILY PRIZE

There will be One (1) daily winner. The daily prize for the winner consists of a cd (1) featuring the artist of the week.
